Reported was the WWTP had outage over weekend, a module went bad. A repair part was obtained from Detroit. The downtown pumps for the WWTP are failing, quotes where obtained to rebuild these pumps in the amount of \$2,965.00, \$2,650.00 and \$2,980.00. Discussion took place on the repair one at a time, though council decided to repair all of them. Perry moved Bonnough 2nd to rebuild all three pumps in the amount not to exceed \$9,000.00, all yes motion carried. Reported on was the injured maintenance worker will be on salary continuation. The flags where placed at half-mast and the Haskins Police Department wore bands of mourning due to the pass of Bill Davisson. Reported was that information was obtained from Financial Design Group who it the village's health insurance broker concerning the availability of dental coverage at the employee cost, more information will come. Discussion on the Hydrant Flushing and the use of the Nixel alert system was discussed. The Nixel alert system was designed for first responders. There is another platform of Nixel that would be a cost to the village of approximately \$2400.00 with the setup fee however more information will be obtained as

it was not known if this was a yearly cost for the Nixel system. A user friendly app for this Nixel or a widget on the village's website may also be a possibility. Penny Getz asked about the boil advisory that was on Facebook, she was told this was Bowling Green how issued this. The 2009 police cruiser should be done being repair this week.
