- E. Reading and disposal of the journal of proceedings: Perry moved Tipton 2nd to approve the journal of proceedings for September 5<sup>th</sup> 2017 council meeting all yes motion carried.
- F. Village Administrator/Police. This report in on file with the clerk. 2 quotes where presented for the paving of the village parking lot that in located next to OR's Sunoco. Perry moved Tipton 2<sup>nd</sup> to accept the quote from Rutter and Dudley in the amount not to exceed \$25,000.00 for the capital projects fund to pave this, all yes motion carried. Phil Tipton asked if this project can be still done this year as in the winter months the asphalt plants will close then.

Tipton moved Gwozdz 2<sup>nd</sup> to accept the quote from Rutter & Dudley for the milling and paving of W. Greenwood from 64 to Liberty Hi in the amount not to exceed \$23,500.00 for the street levy, all yes motion carried. Ms. Helen Bonnough noted the dates on the quotes had a June 30<sup>th</sup> 2017, believing this may have been an oversight. Mr. Carroll reported on the police department side that 2 part-time offices have been hired.

- A. The Haul Road Agreement was presented to council with Dominic Volpe an agent for NEXUS Gas Transmission lines presented information and a brief explanation for this. This agreement will allow the protection of community roads while this work on the Gas line is installed. In the Village of Haskins 3.4 miles of King Road an .25 of the Utility Road back to the WWTP will be utilized. Solicitor Paul Skaff reviewed this agreement that was prepared by the county prosecutor. Mr. Volpe stated that a large bond is issued so the company will make sure all roads will stay the same as a video tape has been taken before it will be taken during and after construction to make sure communities roads are not damaged. Tipton moved Bonnough 2<sup>nd</sup> authoring Mr. Colby Carroll to sign the Haul Road Agreement, all yes motion carried.
