# The Village Council of Haskins met at the townhall.

A. Mayor Nick Thompson called the meeting to order at 7PM with the Pledge of Allegiance being recited. Mayor Thompson also recognizing any former or active Military.

- C. Wright moved Prehn 2<sup>nd</sup> to approve agenda for this evening's meeting all yes with amendments motion carried.
- D. Reports, communications, appointments, and confirmations, from the mayor, directors, of departments, and another village matters:
  - 1. Mary Wright would like to see the website calendar and the journal of proceedings, perhaps having the utility staff to do this weekly.
  - 2. Mary Wright asked for a follow up on the speed study for the village, she explained this to those in attendance. The speed limits that are on State Route 64 are controlled by the State, however some feel these speeds are not conducive with the village. Mr. Carroll will contact ODOT concerning this.
  - 3. Mary Wright also stated she has spoken with Mr. Carroll to prepare on power point on the WWTP and the Electric to help residents understand on how this works and are billed. This will be good to place on the website and have this information available.
- E. Reading and disposal of the journal of proceedings: Prehn moved Vogelsong 2nd to approve the journal or proceedings the regular council meeting held on June 2<sup>nd</sup> 2025 all yes motion carried.
- F. Village Administrator/Police Reported on:
  - 1. No new update on the ODOT Safety Grant
  - 2. No new update on downtown sidewalks however Feller & Finch will be sending updated pricing.
  - 3. AMI- The Member Schedule has been received.
  - 4. King Road property interest, a Data Center which will double the load by May of 26 and 8.2MW by 2030.
  - 5. WWTP will have a June Demo with Jones & Henry to review.

- 6. The USPS was emailed for an update for the village. Mayor Thompson stated they are now waiting for approval from Bowling Green as to the boxes and route.
- 7. Mr. Carroll has scheduled a townhall meeting with all the of the Business's in town, this will be held on July 23<sup>rd</sup> at 9AM. This will hopefully continue and allow the village to get input and keep business up to date on village activities.
- G. Public Presentations and Hearings: Jeremy Harpel proposed to council the J & B Tree Farm, the proposal he had given to Planning Commission. After review of this proposal council, Mary Wright stated that she does not like to idea of boxing in the Waste Water Treatment Plant (this property is on King Road) and not allowing much room for growth. Spencer Elfring asked what the Planning Commission had thought on this proposal. Mary Wright also asked where the figures came from for the cost per acre as she feels this proposal is undervalued. Jeremy Harpel addressed these questions. Mayor Thompson stated with the proposal for the data center with the idea of this center putting in a substation, allowing council to have more information for the next meeting. Ms. Meyer in attendance asked on how residents in the village know when land is up for sale by the village, the mayor explained this process.

- 1. The Fiscal Officer presented the Estimate of Resources for Fiscal Year 2026 with Wright moving Elfring 2<sup>nd</sup> to approve this and send to the Wood County Auditor, all yes by voice roll call motion stands adopted.

  - **B. Public Safety:** Mary Wright thanked Mr. Carroll for the update on the PD schedule, this is still finalized with coverage working. The village wide garage sales days and on the 4<sup>th</sup> of July there was PD coverage with parttime officers. Weekends and evening are covered with day time hours being covered by parttime. Mr. Carroll is working on the in-car camera systems for the cruisers.
  - C. Streets and Utilities: Jason Vogelsong asked about the blowers at the WWTP. The road crack sealing will be begin soon along with the concrete bunkers at Lusher Park being placed. Smoke testing and the 2<sup>nd</sup> entrance/exit for Logan Meadows. Mr. Vogelsong does not want to see these issues slip through the cracks.

  - **F. Facilities and Grounds:** An updated map from Feller & Finch is needed to have a general idea for how much area is located for the park. A quote for picnic tables and benches is needed to apply for the WCPD Grant.
