The Village Council of Haskins met at the townhall.

Joe Pemberton from Suburban Natural Gas discussed the pending gas rate increase, field operations and public safety awareness for Suburban. The PUCO rate increase as ordered by the commission is looking to be 6.67%. This increase is every 7 years, the last one in 2018. The leak survey went well, and making sure everyone is aware to call 811 before they dig.

4. Mr. Harpel will find out where the status of sidewalk study stands.
5. Mr. Haydel is waiting on finding out what is exactly needed for the manholes the village owns that did not pass the smoke testing. This will be completed soon along with notifying the residents whose homes did not pass this smoke test.
6. The ice rink is going up this year, perhaps going at the corner of Church and Main Street.
7. The lighted parade flyers went in the utility bills. The wagon is being worked on for this parage. The Otsego Band will be marching and food vendor trucks.

L Miscellaneous business (discussion of matter of general interest, communications, petitions and claims.


1. Mary Wright noticed the pickle ball net is broken. This net has been taken down for the winter and it will be repaired next spring.
