

VILLAGE OF HASKINS, WOOD COUNTY, OHIO

ORDINANCE NO. 2025-1

AN ORDINANCE TO MODIFY SPEED LIMIT ON STATE ROUTE 64

WHEREAS, the Village of Haskins is a statutory village located in Wood County, Ohio, and

WHEREAS, the Village has powers of local self-government, including the power to establish speed limits on streets located in the Village, and

WHEREAS, after securing a traffic study performed by the Ohio Department of Transportation, (ODOT), attached Exhibit B, the Village desires to modify the previously established speed limits on State Route 64 within the Village of Haskins.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Haskins, Ohio, that:

1. State Route 64, beginning at the Village south corporate limit to Lusher Park, a distance of 0.76 miles, is hereby declared to be a 50 mile per hour zone in both north and south directions.
2. State Route 64, beginning at Lusher Park to Greenwood Drive, a distance of 0.55 miles, is hereby declared to be a 35 mile per hour zone in both north and south directions.
3. State Route 64, beginning at Greenwood Drive to King Road, a length of 0.20 miles, is hereby declared to be a 50 mile per hour zone in both north and south directions.
4. State Route 64, north of King Road to the Village north corporate limit is hereby declared to be a 55 mile per hour zone in both north and south directions.
5. Attached hereto and marked Exhibit A is a map depicting the speed limits established hereby and said map is incorporated herein.
6. The Village Streets Department is hereby directed to take all reasonable measures to ensure the traveling public is made aware of these changes, including, but not limited to, the erection of one or more National Highway Traffic Safety Administration Manual approved street signs establishing said speed limits, visible to north-bound and south-bound traffic, and to take any other measures reasonably believed to be necessary to lessen the risk of injury as a result of this change.
7. The Village Clerk-Treasurer is hereby directed to publish notice of this Ordinance in a newspaper of general circulation once per week for two consecutive weeks, and on the Village's website.
8. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
